

The 2023 season has sure been a wild one. Here in Berks, we have had a surprisingly busy fall. Between more rainfall and warmer early October temperatures, adult mosquito surveillance is slated to continue until the end of October. We even had WNV positives roll in as recent as last week.

Hopefully with the shorter days and cooler temperatures, we will start to see a decline in mosquito activity. Even though mosquito season is coming to an end and populations are beginning to dwindle, I still recommend taking the proper precautions. Removing standing water and wearing bug spray will still reduce the risk of people contracting West Nile.

2023 Season Wrap-up

I'm a big fan of fun facts and statistics, and since the busy season is over, I figured I would provide you all with some basic numbers from the 2023 season here in Berks.

- <u>651</u> gravid traps were set
- For a total of 27,043 mosquitoes collected
- With an average of 42.07 per trap
- <u>939</u> mosquito pools were created to test for West Nile
- With 78 of those pools testing positive for WNV

To put that into perspective, the last 5 years have received the following positive samples:

- 2018-362
- 2019-37
- 2020-19
- 2021-62
- 2022-153
- 2023-78



As you can see, positive results can vary each year. Since we can never truly predict the weather, general mosquito habitat prevent efforts are incredibly important. You all have been very helpful this season in aiding in removal of habitat was well as helping to educate residents. Whether it was posting materials on social media pages & websites or allowing us entry in sewage treatment plants, all of your help this season is greatly appreciated.
