Major Systems Program

On behalf of the County of Berks, the Redevelopment Authority of the County of Berks (BCRA) is administering the Major Systems Program. The Program is designed to assist low-income families who own and occupy an attached or detached single-family home in need of a repair or replacement of a major system of their house. This assistance is in the form of a one-time deferred payment loan and must be used for an item or items that threatens the health, safety, or welfare of the household. The house must be located in a borough or township of Berks County. The Program may be funded by federal, state, or local sources.

Eligible Uses:

- Replace or Repair Roof
- Replace or Repair Heating System
- Mechanical Repairs and Structural Items
- ADA Fixtures and Ramps
