## A RESOLUTION OF COUNCIL OF THE BOROUGH OF LEESPORT, BERKS COUNTY, PENNSYLVANIA, AMENDING THE FEES CHARGED FOR RENTAL OPERATING LICENSES

**WHEREAS**, the Council of the Borough of Leesport, Berks County, Pennsylvania ("Borough"), enacted a Tenant Registration Ordinance, Ordinance No. 422, on November 15, 2006; and

**WHEREAS**, Section 11 of said Ordinance provides that the cost of a Rental Operating License shall be set forth by Resolution of Borough Council, and shall include the actual cost of the Building Code Official's Inspection Fee; and

**WHEREAS**, pursuant to said Ordinance, the Borough adopted Resolution No. 234-19, which established fees charged for rental operating licenses; and

**WHEREAS,** per the authority provided for in the Tenant Registration Ordinance, the Council of the Borough of Leesport desires to repeal, restate, establish and amend the fees for permits and inspections.

**NOW, THEREFORE, BE IT RESOLVED**, by the Borough Council that the following fees are established in connection with the administration of the Tenant Registration Ordinance:

Fees for the application and inspection for a Rental Operating License:

Application fee

\$25.00

Inspection fee

\$75.00 per rental unit

FURTHER RESOLVED, that this Resolution shall take effect immediately.

**FURTHER RESOLVED**, that if any provision, sentence, clause, section, or part of this Resolution shall for any reason be found to be unconstitutional, illegal or invalid, such determination shall not affect or impair any of the remaining provisions, sentences, clauses, sections, or parts of this Resolution, and it is hereby declared to be the intent of the Borough Council of the Borough of Leesport that this Resolution would have been adopted had such unconstitutional, illegal or invalid provision, sentence, clause, section or part not been included herein.

**FURTHER RESOLVED**, that all Resolutions or parts of Resolutions inconsistent with this Resolution, specifically Resolution No. 234-19, are hereby superseded.
